Cllr Phillips declared an interest in any matter relating to Houghton Wildlife Group. Cllr Lightfoot declared an interest in any matters relating to Houghton Village Hall. Cllr Savory declared an interest in planning application, 21/0930, being a member of Cumbria Wildlife Trust.

One member of the public was in attendance to consider planning application 21/0847. They noted that the road into Tarraby was a single-track road, with no turning places possible, and no support from gritters in inclement weather.

One member of the public was in attendance to update Cllr's regarding planning application 19/0452 at Brunstock. He provided a timeline of events dating from the last Parish Council meeting to date, with the outcome ultimately being that he, as a resident, has been denied his ability to participate in the planning process and a query remains as to whether the City Council have acted *ultra vires* in making the planning decision. Subsequent legal action, press involvement and reports to the planning and local government ombudsmen to report maladministration, may follow.

It was agreed that ward councillor support is vital and that the local MP should also be involved.
